Part-year residents are taxed on all income received while living in Idaho, plus any income received from Idaho sources while living outside of Idaho. Nonresidents are taxed only on income from Idaho sources. Tax rate. The income tax rate ranges from 1.125% to 6.925% on Idaho taxable income.
